Vice-President Stewart motioned for the Board to approve Attorney Cajoleas' HB 1312 proposed guidelines for salon owners. Board Member Rossi seconded the motion, and the motion carried unanimously (3-0).

Vice-President Stewart motioned that the Board adopt the alternative guidelines for salon owners who allow an unlicensed person performing services of makeup artistry, threading, applying and/or removing eyelash extensions, or any combination of those three services, to share a workspace or workstation with a licensed practitioner. Board Member Rossi seconded the motion, and the motion carried unanimously (3-0).

President Coker asked for a motion to enter executive session.

Secretary Ennis motioned to enter executive session. Board Member Rossi seconded the motion, and the motion was carried (3-0).

Member Rossi motioned for the Board to approve Territory 2 Inspector candidate, Tonya Billips, for hire. Secretary Ennis seconded the motion, and the motion carried unanimously (3-0).

Vice-President Stewart motioned for the Board to Member Bills seconded the motion, and the motion was carried unanimously (3-0).






